Our Forum speaker is Keith Morrison, Battalion Chief of the Special Operations — Urban Search and Rescue of the Fairfax County Fire and Rescue Department. The Chief will share compelling pictures of the search and rescue operations in Haiti and from other major earthquake sites such as China and Peru. Who are the members of this special team, how are they trained and organized, how are they equipped, how is the mission coordinated with other rescue services and with the host country? For terrible flooding, hurricanes, cyclones, and devastating earthquakes, Task Force 1 has been called into action within the United States and all over the world. As a result of rigorous testing and standards, Virginia Task Force 1 has earned a special United Nations classification. The United States is only the third country in the world to have received this status, and Virginia Task Force 1 is the only outfit in the U.S. to have achieved this rank. We are honored to have the Chief with us. Bring your questions to the Forum.





**April 23** will be the second attempt for the Occoquan Park, but we are going to it differently. Take 95 South until Exit 160, and go North on 123. Once you have crossed a bridge over the Occoquan River, the park is the next right at a light. Enter the park and go down a big hill to park by the main building. 


## Two Courses Have Relocated

## Nominating Committee Slate of Candidates for Office and for Board of Directors

### **For President – Paul Hopler**

Paul is a member of the Board of Directors and currently is President. Having joined the Institute in 2003, he has served as chairman of the Curriculum Committee and now is in his second term as a member of the Board of Directors. Paul received his Bachelor of Engineering degree from Rutgers University and his Masters of Engineering from George Washington University. After coming to Northern Virginia in 1960, he started work for the Army Engineer Research and Development Laboratories and then finished his career in the Office of Secretary of Defense as Director of International Cooperative R&D Programs from which he retired in 1996. He loves traveling, technology and skiing and is active in his church and other volunteer organizations. Paul is married to Bonnie Hopler, who also is active in LLI, and enjoys spending time with his 10 grandchildren.

### **For Board of Directors (3-year term) and for Vice President – Bob Huley**

Bob is a member of the Board of Directors and currently is Vice President. A member of LLI since 2004, he has served on the Board since June 2007. He currently is chair of the Budget and Finance Committee, head of the Bridge Special Interest Group, a member of the Trip Committee, and has assisted with several LLI activities.
